This letter is to advise that Red Lion Controls has reviewed the requirements of RoHS Directive 2011/65/EU (RoHS-2), amendment Directive 2015/863 and its connection to CE Marking. Red Lion Controls continues to perform the appropriate testing, using current standards, to confirm Safety (Directive 2014/35/EU) & Electromagnetic Compatibility (Directive 2014/30/EU) of our products. In addition, we have confirmed the RoHS-2 (Directive 2011/65/EU) compliance-exemption status of our products. We will only apply the CE Marking to products that comply (including RoHS-2 exemptions) with the complete requirements of these combined Directives.

Red Lion Controls ensures product meet the requirements of the RoHS Directives in that they do not exceed the limits for:

- Mercury (Hg) (0,1 %)
- Cadmium (Cd) (0,01 %)
- Hexavalent chromium (Cr VI) (0,1 %)
- Polybrominated biphenyls (PBB) (0,1 %)
- Polybrominated diphenyl ethers (PBDE) (0,1 %)
- Bis(2-Ethylhexyl) phthalate (DEHP) (0,1 %)
- Benzyl butyl phthalate (BBP) (0,1 %)
- Dibutyl phthalate (DBP) (0,1 %)
- Diisobutyl phthalate (DIBP) (0,1 %)

This letter is also to advise that based on information from our suppliers, the component parts and materials supplied to Red Lion Controls do not contain any "hazardous substances" and no "hazardous substances" are added to our products during the manufacturing process. Red Lion Controls is continually working with our suppliers to ensure that we fully comply with Directive 2015/863 in it's entirety, including Category 9 (monitoring and control equipment) whose deadline is the 22 July 2021.
