


Model CRA000 AD070 70000 - G307K to CRx00007 Adapter Plate Bulletin


GENERAL DESCRIPTION

The Model CRA000 AD070 70000 adapter plate provides the necessary hardware to install a CRx000 07 into an existing G307K2 cutout. This panel is made out of black Polycarbonate plastic that matches the material used on the CRx00007 HMI. Included in the kit are the adapter plate (with pre-attached gasket) and a mounting stiffener/plate required to meet any NEMA 4X/IP65 (Face only) application.


DIMENSIONS In inches (mm)

After Installation Back View




INSTALLATION PROCEDURE

1. Ensure the gasket on the CRx00007 is properly in place. Slide the CRx00007 through the adapter plate and then through the front of the cutout in the existing panel. The CRx00007 sits in a recess in the adapter plate. The adapter plate sits in the cutout.
2. Discard the mounting plate shipped with the CRx00007. Place the mounting plate shipped with the adapter plate on the rear of the CRx00007 from the inside of the cutout.
3. Hook the clamps to the slots in the CRx00007 assembly and position the screws in the anti-walk features provided on the plate. See diagram below.
4. Tighten the screws against the mounting plate. The minimum torque to ensure a NEMA 4X/IP65 water seal is 4.0 lbf-in (0.45 Nm). The maximum torque is 5.0 lbf-in (0.57 Nm).
CAUTION: DO NOT OVER TIGHTEN THE CLAMPS.
